INNOVATION & CONNECTION: NC FJC AND COLLABORTIAVE **COMMUNITIES CONFERENCE**

On November 13-14, we hosted the 6th North Carolina Family Justice Center and Collaborative Communities Conference. Over 500 gathered for this dynamic learning event. Presenters included Questyn Hinton (17 yrs), a Camp HOPE program participant since 2017, a multitude of survivors sharing their truth and insight, FJC founders Casey Gwinn and Gael Strack, and an array of professionals in child and elder abuse and domestic and sexual violence. In her opening remarks, Questyn shared a phrase she learned at Camp HOPE, "My VOICE has Power." In many ways, these words became a mantra for the event as speakers amplified the importance of using one's voice to create positive change.









The first NC FJC Conference was held in 2017 at the International Civil Rights Museum. The goal was to inspire communities to collaborate and create FJCs, best practices, and life-saving models for providing wraparound care for survivors and increasing accountability for those who harm. As a result of our work here in Guilford County, we have inspired the development of 8 additional FJCs in our state!

Our partnership is proud to share the collective impact of our work, and are reaffirmed time and time again through the stories of survivors who highlight the long-term effects the FJC partnership has had on their lives.

This event was the second-largest gathering of FJC professionals in the country. We certainly have much to celebrate. We also know that many obstacles still exist, and our work must continue to charge ahead, innovate, and advocate for the needs of survivors and their families.

SURVIVOR SPOTLIGHT

Karshena "Storm" McCain

Survivor, Camp HOPE Parent, Volunteer Court Navigator

For years, Karshena suffered from emotional and financial abuse in silence. As the abuse in her home escalated, Karshena attempted to share her pain with loved ones in her family and faith community. When asked if her husband ever hit her, she replied no, and was given the advice to stick it out. Karshena felt trapped. She had given up everything for this relationship, and now her husband controlled everything, like her access to money and if she was allowed to spend time with friends and family.





It wasn't until her ex-husband turned his abuse on their 11-year-old son that Karshena learned about the Family Justice Center. After coming to the FJC, Karshena shared that it was the first time in her life that she didn't feel shame or blame for seeking help. She filed a restraining order and worked with the DA's office and law enforcement to hold her abuser accountable. This marked the beginning of her transformation from a victim to a survivor. Karshena and her son started a new pathway of hope and healing. She shared her inspiring story with an audience of over 500 at last month's NC FJC Conference! Today, Karshena and her son are thriving as active members of the FJC's Camp HOPE program. Karshena even volunteers as an FJC Court Navigator to support other survivors!

ADVANCING ELDER JUSTICE



Supported by the NC School of Government our Elder Justice Committee drafted legislation on establishing elder abuse multidisciplinary teams across the state to enhance the safety of

vulnerable adults. The Committee also held the first ever "Day of Service" with Meals on Wheels in High Point and Greensboro.

EMPOWERING SURVIVORS

VOICES led a dynamic training on domestic violence in the Workplace for a packed room of leaders and local employers, while also teaming up with the FJC to support survivors in the courtroom with the new



Volunteer Court Navigator program.

VOLUNTEERING FOR IMPACT



Hope is growing and so are the number of volunteers dedicating their time and talents to the FJC. This year more than 120 volunteers supported FJC operations, training and outreach, court navigation, Camp

HOPE, and mental health counseling!
