NEW BUSINESS:

Major Subdivision Case 18-09-GCPL-05602: Pleasant Oaks Estates Preliminary Plat: This is a request to approve the preliminary plat for Pleasant Oaks Estates subdivision. Property is located near the intersection of Pleasant Ridge Rd. and Pleasant Oaks Rd., Guilford County Tax Parcels 0148458 & 0148468 approximately 47 acres. Zoning: RS-40. (Hagen Engineering, PA)

Planning Comments: (Matt Talbott, 641-3591)

- 1. Note setbacks for corner lots.
- 2. Note on plat that Lot 19 should be addressed and be accessed off Dawning, not Rambling.

<u>Watershed Comments:</u> (Frank Park, 641-3753)

- 1. Provide a typical stream buffer sectional detail.
- 2. PE seal and signature is missing.
- 3. Deed Restriction-Restrictive Covenant note is missing.
- 4. At the end of lots 3 and 10, 60 feet drainage easement shall be changed to 110 feet stream and drainage easement.

Environmental Health Comments: (John Nykamp, 641-4807)

1. ADVISORY NOTE: Utility Easement for Guilford County Schools contains Force Sewer Main. This may affect well locations on Lots 8, 9, 10, 11, 12, 13, 20, 21, 22, 23, 24, 25, 26, and 27.

NCDOT Comments: (Ernie Wilson, 487-0100)

1. Rambling Rd. should have 60' RoW.

Frank motioned for Conditional Approval (CA). Beth Anne seconded. The motioned carried unanimously.
